



## ACTION & ACCOUNTABILITY

November is Woman Abuse Prevention Month, which includes the 16 Days of Activism against Gender-Based Violence, a global campaign calling for an end to gender-based violence. It begins on November 25th, the International Day for the Elimination of Violence Against Women, includes The National Day of Remembrance and Action on Violence Against Women on December 6th, and ends on December 10th: Human Rights Day.

Thunder Bay City Council formally declared GBV and IPV an epidemic on September 25th immediately following our deputation. In addition, City officials have invited us to present to the local social services administration board and the Intergovernmental Affairs committee, and also supply a list of actionable goals for City Council to better support survivors of GBV in our community.

Our 2023 16 Days campaign will focus on these actionable goals – efforts at the municipal and personal levels to address gender-based violence.



- Many other cities are taking further steps to educate their communities and support solutions for GBV (i.e, York region). Gender-based violence is a structural problem that requires structural solutions.
- Services, policies and protocols are often weaponized by abusers against women and children.
- Thunder Bay City Council asked us to provide additional recommendations to help address IPV/GBV on a municipal level. What will accountability look like?

## ACTION

- Ensure Thunder Bay's Community Safety and Well-Being Advisory continues to prioritize GBV and specifically 2SMMIWG.
- Schedule an annual, GBV-dedicated meeting or presentation by TBDCCEWA and Naadmaagewin IDVC to TBDSSAB, City Council.
- Develop mechanisms to do annual case reviews of IPV cases for all agencies and institutions concerned to track trends and measure improvement.
- All City and District services (and other organizations) should undertake and complete an
  internal policy scan to evaluate policies and protocols that form their current response to
  cases of GBV. This data should be collated and reviewed by the Community Safety and
  Well-Being Advisory for compliance with existing laws and scholarship regarding
  effective response to GBV. The City / CSWB should then develop a minimum, mandatory
  standard policy for all services regarding differential response to clients, employees, and
  practices that encompass experience or perpetration of GBV.
- Fund court watch programs.
- Engage in collective advocacy for related community-based supports: housing, mental health and addictions treatment options
- Service Providers: avoid becoming complicit in abuser's attempts to exploit their expartners and children.
- Sanction those who are perpetrating violence and coercive control using power and privilege that is assigned to them as part of their job or position in the community.
